2023-24 School Description and Mission Statement

Philistine Rondo School of Discovery is a STEAM magnet school featuring project based learning as our shared instructional approach. Rondo is also a Leader in Me school which means we believe that all students can be leaders because they must first lead themselves. We teach students how to lead themselves using the 7 Habits of Highly Effective People and the 4 Disciplines of Execution. With leadership as our operating system, students are empowered to take responsibility for their own learning and embrace productive struggle knowing it is expected to be wrong on your way to being right.

Rondo School of Discovery also features a Mandarin Immersion program. Some of our students starting in kindergarten have half of their instruction in English and half in Simplified Mandarin. This program is now in 8 classes kindergarten through third grade and will continue to add to the program as the first class matriculates up.

Rondo School of Discovery is a year round school with four tracks for Transitional Kindergarten through 6th grade. Students attend school for three months and then have one month off with each track featuring different months off.

The mission of Philistine Rondo School of Discovery is to empower students to be the leaders, thinkers, collaborators, and problem solvers of the 21st Century. We focus on technology integration in lessons, an engineering design process as part of our project based learning tasks, the science of reading instruction, and tier one instruction that includes small group instruction in ELA and math. We have a robust MTSS which monitors student learning and provides extra support for students who need it in a timely and comprehensive way. Our staff includes three teachers on special assignment to support the Mandarin Immersion Program, reading instruction and general year round school needs.

2023-24 Quality, Currency, Availability of Textbooks and Other Instructional Materials

All textbooks used in the core curriculum are aligned to the California State Standards. Instructional materials are selected from the state's most recent list of standards-based materials and adopted by the State Board of Education. The district follows the State Board of Education's eight-year adoption cycle for core content materials (English/language arts, math, science, and social science).

On Tuesday, September 5, 2023, the Corona-Norco Unified School District's Board of Education held a public hearing to certify the extent to which textbooks and instructional materials have been provided to students. The Board of Education adopted Resolution No. 37 which certifies as required by Education Code §60119 (1) that textbooks and instructional materials were provided to all students, including English learners, in the district to the extent that each pupil has a textbook or instructional materials, or both, to use in class and to take home, and (2) sufficient textbooks and instructional materials were provided to each student, including English learners, that are aligned to the academic content standards and consistent with the cycles and content of the curriculum frameworks in math, science, history-social science, and English/language arts.

In addition to core subject areas, districts are required to disclose in their SARCs the sufficiency of instructional materials used for their visual/performing arts curricula. During the 2023-24 school year, Corona-Norco Unified School District provided each student, including English learners, enrolled in a visual/performing arts class with a textbook or instructional materials to use in class and to take home. Professional Development

All training and curriculum development activities at Philistine Rondo School of Discovery revolve around the California State Standards. Decisions concerning selection of staff development activities are performed by all staff using tools such as teacher input and data analysis, to determine the areas in which additional teacher training may enhance classroom instruction and increase student achievement levels. Rondo School of Discovery supports ongoing professional growth throughout the year. Teachers meet with department level teams to conduct data analysis to identify areas of need. Teaching staff are provided the opportunity to participate in district-sponsored staff development workshops or training session as 1) a supplement to site-based staff development, 2) for reinforcement of or follow-up on previous training, or 3) follow-up training for newly implemented programs/curricula. Philistine Rondo School of Discovery offers support to new and veteran teachers through peer coaching and mentoring. Instructional aides and paraeducators are provided targeted training focused on teaching strategies and curriculum content. Substitute teachers are invited to participate in designated staff development activities. All staff are encouraged to attend professional workshops and conferences. Classified support staff receive job-related training from department supervisors and district representatives.

Professional Learning is aligned to the CNUSD Strategic Plan and must have an area of focus in order to be financially supported at the district level. Academic Excellence, Student Well-Being, Equity, and Effective Governance are the four target areas of the Strategic Plan.

1. In 2021-2022, CNUSD had 272 professional learning titles with 737 sessions lasting from 1- 8 hours. CNUSD logged 11,718 staff members attending sessions throughout the year.

Professional Development

In 2022-2023, CNUSD had 265 professional learning titles with 671 sessions ranging from 1- 8 hours, depending on the training and the setting. CNUSD logged 11,512 staff members attending sessions throughout the year.

For 2023-2024, CNUSD plans 315 professional learning sessions ranging from 1-8 hours for certificated and classified. This includes several training sessions accessed by every educator during teacher training days.
